



\* Only editions. A thorough account of excise and revenue laws in the early Federal era with tables and an appendix of forms that gives a glimpse into the enforcement of the law by customs officers. Separately published, the *Supplement* is often bound with copies of the *Digest*.


### 2. American Civil Liberties Union.

Stapled pamphlet in self-wrappers. Moderate toning, pencil annotations (shelfmarks) to first leaf, which has a small clean tear to its fore-edge not affecting text, ink stamps to front wrapper and final page, internally clean. Item housed in custom 9-1/4" x 5-3/4" cloth folder. \$350.

\* Only edition. This pamphlet, an "extraordinary record of attacks upon the liberty of a religious organization," was produced by the American Civil Liberties Union and prominent supporters in order to bring attention to the persecution of Jehovah's Witnesses, who were conscientious objectors to American participation in World War II. It encourages "vigorous action" in order to "maintain those liberties of speech, press and conscience so essential to us all in a democracy."



\* Only English edition, published in Yiddish the same year. The American Zion Commonwealth was established in 1914 by American Zionists for the purpose of purchasing land in Palestine for Jewish settlements. Suspended during World War I, it became active after the Balfour Declaration and the Mandate for Palestine and established several large and well-known settlements still populated today.

Probably produced for fundraising purposes, this pamphlet describes the group's mission and business model as not only a business enterprise, but a social and political project: "It is our firm purpose to enlist in our ranks all those who see in Zionism not only a political project but a social ideal." Notably, it compares the Commonwealth to the British East India Company and holds up the latter's blend of political power and business acumen as a blueprint for the Commonwealth, though it disavows "the longing to live on luxuries secured by the toil of conquered subjects." The pamphlet also includes the group's articles of agreement with the Zionist Organization of America and an excerpt from "Justice Brandeis in Palestine."

This is a rare item. OCLC locates 1 copy worldwide (National Library of Israel).

\* Signed in type by Paul Barras and Louis Marie de La Révellière-Lépeaux, this broadside announces the Coup d'etat of 18 Fructador (September 4, 1797), a turning point of the French Revolution. Initiated by three members of the Directory, Barras, Révellière-Lépeaux and Jean-François Rewbell, this coup was motivated by a fear that recently elected legislative majorities would attempt to restore the monarchy. As Cobban notes, the "legislative bodies were purged, the elections of forty-nine departments quashed, all opposition journals suppressed, and seventeen of the more prominent enemies of [Barras, Rewbell and Révellière-Lépeaux] dispatched to the 'dry guillotine,' French Guiana, where eight of them rapidly died. A few hundred priests were also sent to Guiana, and a similar number of other opponents of the régime were tried by military courts and shot. For a short period it was a new Terror, but one inspired not by republican ardour but by political calculation. The Republic had been saved and even the appearance of liberty lost. With the aid of the army the politicians of the Directory still held precariously to their power and kept the centre of the stage, but the tramp of marching men increasingly drowned their voices, and from the wings the figure of Bonaparte cast a deepening shadow."

Moderate rubbing and a few scuffs and stains to boards, which are partially detached but secure, heavier rubbing to extremities with notable wear to spine ends and corners. Light toning to interior, light soiling and offsetting to preliminaries and final few leaves, chips, tears and corner folds in places, inkstains and spark burns to a few leaves, endleaves and margins of several other leaves throughout volume filled with annotations in a contemporary hand. \$2,500.

\* Later editions. A work of immense authority for generations, Coke's *Reports* are not reports in the conventional sense; they are highly detailed anthologies of precedents organized by topic. Taken together, the *Reports* form the most extensive and detailed treatment of common law pleading that had yet appeared. The first editions, all in Law-French, were first published in 1600, 1602, 1602, 1604, 1605, 1607, 1608, 1611, 1613, 1614, 1615. After Coke's death editors compiled a "General Table" to Parts 1-11, which was first published in 1652, and two more parts, which were first published in 1656 and 1659. (The first edition in English, which did not include pleadings, was published in 1658.)

The thoughtful annotations throughout this volume, all in English, are probably the work of a law student. Those filling the endleaves and other large blank spaces in the text are summaries of selected cases. All are about a paragraph in length. Annotations to the text, sometimes accompanied by underlining, are glosses or summaries of important points.



\* Signed by justices of the peace Isaac Huntington and Ebenezer Backus, respectively, these documents order local sheriffs to enforce the payment of costs incurred in lawsuits. The 1749 document also explicitly empowers the sheriff to imprison a recalcitrant debtor for non-payment.



\* Denman served as a judge on the Ninth Circuit Court of Appeals from 1935 until his death (assuming senior status in 1957). He supported Brandeis's nomination to the Supreme Court and worked with him on the cases that defended the constitutionality of California's Eight Hour Law for Women. In this address, he looks back on fond memories of Brandeis and attempts to paint a picture of his personality.





\* First edition. The inscription reads: "For Ralph Baker, with his warm regards. F.F." Mr. Justice Holmes is Frankfurter's finest statements of his admiration for Holmes. This and other books did much to establish Holmes's posthumous reputation. Ralph Baker [1888-1966] was a law professor at Harvard from 1932 to 1958. He specialized in trust and corporation law.



\* Reprinted from *Foreign Affairs*, Volume 9, Number 3 (April 1931), pp. 409-434. Like his friend and colleague Louis Brandeis, Frankfurter was a prominent and enthusiastic Zionist. In this article, he praises the progress of the Jewish settlement of Palestine: "There Jews are living and laboring with a joy and ardor felt by Jews probably in no other land. The Arab masses thrive better than in any of the Arab countries surrounding Palestine. And despite the stimulation of religious fanaticism and the blatancy of the doctrinaire, Jew and Arab are collaborating in the thousand intimacies of their common life as builders of a new country." He also discusses the Palestine Mandate and the Balfour Declaration at length.



\* Third edition. Freeman was clerk of courts, a register of probate and a probate judge in Massachusetts. The seventh and final edition of his *Valuable Assistant* was published in 1814. Thomas [1749-1831], an important early Massachusetts printer, newspaper publisher and author, was also the founder of the American Antiquarian Society. Ebenezer Daggett is almost certainly a relative of David Daggett [1764-1851], one of the founders of Yale Law School.



\* This "informal, appreciative and immensely enjoyable" address was the "centerpiece" of Harvard Law School's centennial celebration to mark the anniversary of the birth of Felix Frankfurter. Freund was a clerk for Justice Brandeis from 1932-1933, a civil servant and a legal scholar who taught at Harvard for the majority of his career.



\* Only edition. Published near the end of the first English Civil War, this volume collects ordinances and orders issued during that time. Many relate directly to the war, while others deal with everyday governance or ideological issues such as religious liberty.

Contemporary calf over beveled wooden boards with later rebacking, blind frames and an elaborate pattern of blind ornaments and rules in a diced pattern to boards, raised bands and lettering piece to spine, one buckle from clasp to rear board, hinges reinforced, rear pastedown from early vellum manuscript leaf. Moderate rubbing, a few scratches and scuffs to boards, corners worn, rear hinge cracked, armorial bookplate of Sir John Cope and bookplate of George Dunn to front pastedown, nineteenth or early twentieth-century sale record tipped-in to front free endpaper, pencil annotations in Dunn's hand to endleaves. \* The *Decretals* of Gregory IX is the first authentic general collection of papal decrees and constitutions. Compiled by Raymond of Penaforte at the request of Pope Gregory IX in 1230-1234 and promulgated in 1234, it is one of the collections known collectively as the *Corpus Juris Canonici*. Our copy includes its most important commentary, the so-called *Glossa Ordinaria* of Bernard of Botone (*Bernardus Parmensis*), which was written around 1263.

Our copy had two notable owners. Cope [1673-1749], 6th Baronet, sat in the House of Commons (as a Whig) for 36 years and was a director of the Bank of England from 1706 to 1721. Dunn [1865-1912] was a notable bibliophile who owned a distinguished collection of early books in contemporary bindings. One of his notes indicates that he purchased the book in 1902. (The book was sold in the third Dunn sale, at Sotheby's London in November 1917.) It is easy to see why it attracted him. It has a handsome early English book binding with distinctive tooling to the board edges featuring an oblong image of a hound pursuing a boar. This tool is not found in Oldhams's list of tools on English bindings and does not appear to be recorded elsewhere. Dunn notes: "the 'Pig & Dog' tool especially good." Dunn also identified dates of 1491 and 1492 in the manuscript leaf, which contains descriptions of remedies for colic and stone and refers to Hanwell, a small village in Oxfordshire.





Contemporary paneled calf, rebacked, blind rules and corner fleurons to boards, raised bands, blind fillets, lettering piece and gilt date to spine, gilt tooling to board edges, edges of text block rouged, hinges reinforced. Light rubbing and some scuffs, scratches and small stains to boards, rubbing and light wear to board edges, corners bumped and worn, front joint cracked, hinges starting, later and recent bookplates (of William Priestly, The Halifax Literary and Philosophical Society, Craig Burns and Dr. and Mrs. H.R. Knohl) to front pastedown and free endpaper, front endleaves detached. Light toning to interior, occasional very faint dampstaining to lower outer corner not affecting text, light soiling to title page, light soiling to margins in a few places, small fox-spots to a few leaves. \$3,500.

\* First edition of the first complete translation in English. First published in Paris in 1625, *The Rights of War and Peace* established the system of modern public international law, based on the concept of "*droit naturel*," a morality-based law that superseded the personalities of individuals or nations. Grotius describes the situations in which war is a valid tool of law enforcement and outlines the principles of armed combat. Though based on Christian natural law, Grotius advanced the novel argument that his system would still be valid if it lacked a divine basis. In this regard he pointed to the future by moving international law in a secular direction.

The first English edition, an abridged translation by Clement Barksdale, was published in London in 1654. It was reissued twice in 1655. This translation by Evats, which includes original notes, followed in 1682. These early English translations, both by Oxford-based theologians, mark an important phase in the reception history of this book. These projects were undertaken due to the author's reputation as a leading Protestant scholar and a faith-motivated desire to reduce international conflict.

\* Second and final American edition, based on the London edition of 1810, to which it is star-paged. Laws was one of the first English jurists to cite Story. "In publishing...the present edition, it has been deemed advisable to select such American authorities as illustrated, confirmed or impugned the doctrines of the text. To this object the notes are exclusively confined; and in no instance do they intrude upon the reader the opinions of the Editor [Story]. They have been prepared during the pressure of professional engagements, and within a *prescribed* limitation of time; but it is believed that few cases of general importance have escaped examination, and none will be found cited with substantial inaccuracy" [ix].




\* As the title indicates, this is a lightly corrected manuscript of an English translation of Lecciones de Derecho Constitucional, first published in Santo Domingo in 1887. Hostos was an educator, writer, activist and one of Latin America's first sociologists. After studying law and philosophy at the Complutense University of Madrid, he became a vigorous advocate for Puerto Rican and Cuban independence and an anti-slavery and anti-colonial activist. He also made immense contributions to educational philosophy and pedagogy throughout his career. Lecciones de Derecho Constitucional is a collection of lectures given by Hostos on constitutional theory. The lectures discuss the development and implementation of constitutional law around the world. In his discussion of the United States, he references The Federalist, Story's Commentaries and the Declaration of Independence.


Hunt graduated from New York University Law School in 1898 and opened a law practice, Hunt & Ingle, in the city after graduation. By 1906, he was living in Puerto Rico, but had returned to Massachusetts by 1935. He was an avowed admirer of Hostos, whom he described as "a political philosopher who lived before his time, but whose timeless ideas are sadly needad [sic] by the world today" in an article commemorating the centenary of Hostos's birth. He is described in the article's byline as a jurist and the translator of two other works by Hostos (Moral Social and Sociología). As far as we can tell, none of Hunt's translations were published and no English translation of Lecciones de Derecho Constitucional has appeared to date.



\* Fifth (stated) English edition. De L'Esprit des Lois was one of the landmark works of eighteenth-century political science and an immeasurable influence on jurisprudence and political thought, especially in the Americas. It was a profound influence on the founding fathers, such as Thomas Jefferson, and the framers of the U.S. Constitution. It contained provocative and wide-ranging ideas on the sociology of law, the separation of political powers and the need for checks on a powerful executive office. First published in Geneva in 1748, and first translated into English in 1750, it remains one of the most significant studies of political and legal theory ever written. Based on Montesquieu's study of the English Constitution, this work is important as the first work to propose the separation of powers, an idea incorporated into the U.S. Constitution.







\* This document sets out a bail bond for John P. Bortle and David Ingersoll, residents of Hudson, New York and subjects of a plea of trespass brought by David Tod and Zachariah Seymour. The bond was \$150, a considerable sum equal to the damages Tod and Seymour sought. An interesting feature of this document is the presence of an additional related form on the verso, which is not completed in our example. The document is also dated for the 1780s, but was evidently repurposed well into the following decade.





\* Only edition, reprinted from the proceedings of the fourth annual meeting of the American Bar Association. In addition to many other state and federal political and legal positions, Taney was chief justice of the United States Supreme Court from 1836 until his death in 1864. He is best known as the author of the majority opinion in the notorious Dred Scott decision (1857), which held that enslaved people residing in a free state or territory were not entitled to their freedom and that Black Americans were not and could never be citizens of the United States.

Though the Dred Scott decision made Taney an object of disdain among some of his contemporaries, he was also praised by many and garnered respect during his long career in public service. This address reviews his career and compares his term on the Supreme Court with that of his predecessor, John Marshall. It is largely effusive in its praise for Taney, to whom Potter refers as "[in] the highest and best sense a Christian, a lawyer and a gentleman." Potter also emphasizes the distinction between Taney's writing in the Dred Scott opinion and his conduct and beliefs in his personal life, which were largely anti-slavery.



Originally published in 1672 in Latin as *De Officio Hominis et Civis*, this is a synopsis of Pufendorf's *De Jure Naturae et Gentium*, a landmark work that proposed a thorough system of private, public, and international law based on natural law. Beginning with a consideration of fundamental legal ideas and their various divisions, Pufendorf proceeds to a discussion of the validity of customs, the doctrines of necessity and innate human reason. It is significant in part because it develops principles introduced by Grotius and Hobbes. Unlike Hobbes, Pufendorf argued that peace, not war, was the state of nature, and he proposed that international law was not restricted to Christendom.







\* Quistorp: first edition; Risi: only German edition. This volume contains two works that illustrate the early reception of Enlightenment ideas on criminology in Germany. Quistorp, a professor of law at the University or Rostock and later Rector of the University of Bützow, was an authority on criminal law. *Grundsätze*, his principal work, is a general treatise. Likely influenced by Beccaria's *Dei Delitti e Delle Pene* (1764), it advocated a reduction of capital offenses and the abolition of torture to obtain confessions. It went through several editions and issues, the last one in 1828, and was one of the sources of the influential German Penal Code of 1871. Risi was a judge in Milan and one of Beccaria's associates. The work of an anonymous translator, *Abhandlung* is a translation of Risi's *Animadversiones ad Criminalem Jurisprudentiam* (1766), a practical treatise on criminal procedure that incorporated principles drawn from *Dei Delitti e Delle Pene*.





Unlike other examples, which are collections of notes of cases and statutes arranged loosely under headings and sub-headings, Sheppard's is comprised of entries on all branches of the law. The *Epitome* is divided into 170 chapters and arranged alphabetically from "Acceptance" to "Words." Dedicated to Oliver Cromwell, it was inspired, at least in part, by the reforming spirit of the Commonwealth. Notable works that followed Sheppard's example, and went on to inspire the modern legal encyclopedia, are Bacon's *Abridgement* and Comyn's *Digest*.





An important lawyer and philosopher, Green, a friend of Holmes and Peirce, was a leading member of the Metaphysical Club and one of the founders of pragmatism. As a lawyer, his "favorite target was legal formalism-the belief that legal concepts refer to something immutable and determinate. His criticism of legal formalism was Wright's criticism of Spencer's evolutionary philosophy: he thought it treated what were merely tools of analysis as though they named actual entities" (Menand). Green's was the penultimate edition of Story's *Agency*, which was first published in 1839. The final edition, by C.P. Greenough, was published in 1882.



\* Only edition. Jonathan Britain was a notable confidence man. After a long career he was finally caught, convicted and hanged after he attempted to impersonate the son of a woman, one of many he charmed, to whom he sent letters requesting money in the son's name. Despite the evidence, he was so persuasive in his trial that many were convinced he was innocent. The forward in our account details Britain's convoluted trail of forgery. It also illuminates the use of bills of exchange, which was the most common way to remit money in eighteenth-century England.



\* Only edition as a separate report, also published as part of Reports of Cases Argued and Adjudged...January Term, 1837 (36 U.S. 420) in Philadelphia the same year. The Charles River Bridge case centered around a contract dispute between the Charles River Bridge Company and the Massachusetts legislature. The legislature had granted the company a charter to construct a bridge over the Charles River in 1785 but granted another company permission to build a bridge over the river in 1828.

The Charles River Bridge Company, faced with a competing toll-free bridge that would essentially eliminate their revenue from the existing bridge, sued, arguing that the 1785 charter had an implicit guarantee of exclusivity. The Supreme Court decided in favor of Warren Bridge by 5-2. The majority opinion, written by Chief Justice Taney, stated that the contract should be construed narrowly and in favor of public interest: If the Court decided for the Charles River Bridge, transportation improvements would be severely curtailed. Justices Story and Thompson dissented. The verdict was seen as a victory for states' rights by supporters and a failure of the federal government by detractors (among them Daniel Webster and James Kent).

This item is scarce, particularly in commerce. No copy of this Boston imprint has appeared at auction since 1916. OCLC locates 12 copies of this title, 4 in law libraries (Library of Congress, University of Minnesota, Boston College, Harvard). Cohen, *Bibliography of Early American Law* 11595.





Robinson, the San Francisco mayor, and Earl Warren, the former governor of California and Chief Justice of the Supreme Court, both of whom are looking toward the camera.

Warren's letter thanks McVay for good wishes sent to Warren upon his retirement in 1969.




